Important Information

Audit requirement

This declaration must be audited by a registered company auditor before it is lodged with the Election Funding Authority unless you are lodging a 'nil' declaration.

Note: If you are unable to have this declaration audited before 25 August 2008, you are permitted to have it audited with your next declaration for the period 1 July 2008 to 31 December 2008 which is due by 25 February 2009. This declaration must still be lodged on or before 25 August 2008.

How to vouch for political donations

Attach to this declaration the triplicate copy of each receipt or acknowledgement slip issued to the donors who made a political donation to you or for your benefit during the disclosure period. The receipt must contain the name and address of the donor, the ABN of the donor if they are not an individual, the date of the donation, the amount of the donation and the purpose of the donation.

How to vouch for electoral expenditure

Attach to this declaration copies of the invoices received in respect of all advertising and printing expenditure.
