### I/we, being the occupants of the subject property:

1. Have no one living in the household that is capable to assist with bundling or tying green waste and no family members or friends who can assist.
2. Understand that all the requirements of the Booked Waste Services as listed on Council's website must be complied with to ensure collection (except to bundle and tie green waste).
3. Acknowledge that, I/we are responsible for cutting branches to a maximum length of 1.5m and this exemption is only for assistance to bundle and tie pre-cut green waste, presented at kerb. Note: no Council Officer will enter private property to provide assistance.
4. Understand this exemption is for one collection only and a new form will need to be completed every time a booked service is made that requires assistance to bundle and tie green waste.
