To assess this application, an inspection will be undertaken and written advice of the decision will be provided to the applicant. Allow 15 working days for this application to be processed.

When assessing this application the Council Officer will take into account:

- Whether the material can be approved for burning.
- The feasibility of alternate means of disposal, including removal or recycling.
- The potential for direct smoke impacts on neighbours and the surrounding community.
- The quantity of material and length of time the material is likely to burn.
- Cumulative effects of smoke on regional air quality.

Bush fire hazard reduction objectives cannot be taken into account during the assessment of this application. Contact the Rural Fire Service for applications for hazard reduction work.
