Should Council fail to finally determine the application within 6 weeks after it is made, then the local authority is taken, for the purposes of any appeal proceedings, to have refused the application.

Should Council refuse the application for an exemption, or is taken to have refused the application, or imposes a condition on an exemption, the owner of the premises on which the relevant swimming pool is situated is entitled to appeal to the Land and Environment Court against the local authority's refusal or against the condition.

*Possible reasons may be due to the physical nature of the premises; the design or construction of the swimming pool; an adult occupier of the premises in or on which a swimming pool is situated would (because of physical impairment of the occupier) be significantly impeded in gaining access to the swimming pool etc.*
